Parking Rules at Lloyd Park

All vehicles must display a parking pass on weekends and holidays. Season pass holders will be issued up to two parking passes at no cost. Additional parking passes may be purchased by season pass holders for \$5 each. This pass must be displayed in a permanent fashion in the lower left hand side of the windshield on the driver's side. Guest of boaters may obtain a one-day parking pass on-site at no charge. Daily fee boaters must display their receipt on the vehicle dashboard. Failure to display the parking pass may result in a ticket and fine by the Winnetka Police Department.
