## WGC 2011 SATURDAY & SUNDAY PERMANENT TEE TIME INFORMATION

### 2011 LOTTERY

Early bird gets the worm . . .  
an incentive program.

To be eligible the entire group's payments and forms must be turned in complete.

The first twenty lottery groups to get their completed forms in will be put into a drawing. One group will be drawn and each group member will receive a Winnetka Golf Club gift card for \$100.

The second twenty lottery groups to get their completed forms will be put into a drawing with the nineteen non-winning groups from the first twenty. One group will be drawn from these thirty-nine groups and each group member will receive a Winnetka Golf Club gift card for \$50.

Any person referring a new group (*must consist of at least three players who have not been in the Winnetka Golf Club lottery in the last two years*) will receive either: a driver fitting and a new driver or a putter fitting and a new putter. To be eligible, the person making the referral must contact Cortney Miller prior to the group signing up.

### LOTTERY RULES & REGULATIONS

1. Season starting time applications are limited to 50 four-somes for either Saturday or Sunday. Those groups who participated in last year's lottery will have first priority in this year's lottery. Groups are defined as three returning players from the previous season's lottery. Any new lottery openings will be filled by groups, first with 4, 3, 2, 1 and 0 residents. A lottery will be held to determine priority.

2. Season starting times will be limited to the following golf memberships: residents and non-resident 7-day passes. All lottery and golf pass fees must be received by 4 pm Sunday, March 6, at the Winnetka Golf Club.

Any incomplete applications or fees will be returned to the group and could jeopardize participation in this year's lottery.

**Please Note:** If a player participates with more than one group on Saturday and Sunday, then the player will pay the appropriate fees for each day.

3. If any member of the group misrepresents residency, then the group may lose its privilege to participate. All fees must be submitted together or applications will be returned.

4. The season has five, 4-week sessions. Five drawings are held for Saturday and Sunday. Below are the dates and times for each session:

**Session 3:** June 25 - July 17

**Session 4:** July 23 - August 14

**Session 5:** August 20 - September 11

Starting times will alternate every eight and nine minutes. Players must report to the starter 15 minutes before their designated starting times.

5. Drawings to determine the order of starting time selection will be held at 12 noon, Wednesday, March 16, at the Winnetka Golf Clubhouse, 1300 Oak St. Lists for starting time order will be available to participants on Friday, March 18, after 12 noon. At least one person of the group or proxy must be present for the time selection on Saturday morning.

## PERMANENT TEE TIME CANCELLATIONS

Lottery groups will pay an **additional \$100 per person toward a cancellation policy**. Any group not cancelling prior to 48 hours in advance or having fewer than three lottery players at its assigned tee time will be subject to a fine which is deducted from each player's \$100.

The first offense is a \$25 fine from each player's holding account. The second offense is a \$50 fine deducted from each player's holding account and forfeit of the next week's time. The third offense will result in the forfeiture of the remaining balance in the holding account and possible suspension for the remainder of the year's tee times.

Any remaining balance at the end of the lottery season will be paid back in full to the lottery players or can be used as pro shop credit.

**Reminder:** Players must cancel 48 hours in advance.

## 2011 SEASON PASSES

All 2011 season passes will be good for unlimited rounds of golf between opening day and course closing in November. Rounds are considered play on the 18-hole course Monday-Thursday from opening until 4:00 pm, and anytime Friday, Saturday, Sunday and holidays.

## RESIDENCY REQUIREMENTS

To receive the resident discount golf passes, you must provide proof of residency. (Example: driver's license, tax bill, etc.) If you have any questions, contact the Winnetka Golf Club at 847.501.2050, ext. 0.

## GOLF PASS RULES & REGULATIONS

- No application will be accepted without appropriate fees.
- Misrepresentation of any information on this application could jeopardize use of pass.
- No refund for any cause whatsoever will be given for fee payments.
- Golf passes are non-transferrable.

### PLEASE READ! LOTTERY PACE OF PLAY

WGC Staff thanks all players in advance for making this commitment to make Winnetka Golf Club a place for all golfers to enjoy their round of golf at reasonable pace of play. Remember, everyone who that follows you on the course that day will feel the effects of your pace of play. Pace is for the enjoyment of all players.

Any group enrolled in the golf lottery does so with the understanding that players must keep pace with the group in front of them. By enrolling in the golf lottery all players and groups agree to the following:

- Maximum pace of play for Saturday and Sunday will be:  

<b>First Hour:</b> Under 4 Hours	<b>Second Hour:</b> 4 hours
<b>Third Hour:</b> Under 4:10 hours	<b>Fourth Hour:</b> Under 4:15 Finish
- Groups that fail to finish in these times and fail to maintain pace interval (finishing within 9 minutes of the proceeding group) for two consecutive weeks will be fined \$25 per person (from the holding account).
- Groups should choose their lottery times to fit the pace of play that makes for their most enjoyable round.
- Groups failing to meet the above criteria may choose to pay the fine or have their time moved to the end of all lottery times.
- All players on Saturday and Sunday, lottery or not, will agree to this pace of play policy.
- This policy will be waived under the following conditions: no golf cars are allowed, it is raining during your round and it is more than 90 degrees during your round.

Staff rangers are here to help all golfers enjoy a safe and well-paced round of golf. To that end, the following will occur when a group is found to be out of position to finish the round in acceptable pace.

#### 1st Step

Winnetka ranger will ask to please improve your speed of play. Can we help?

#### 2nd Step

If your group has not improved its position, the group will be asked to move into position by skipping the necessary amount of holes or shots.

#### 3rd Step

If your group cannot maintain position, the group will be asked to return to the pro shop for a refund of their golf fees.
