Lottery Rules & Regulations

- » The lottery draw will be held on Friday, April 30 at 10am at the A.C. Nielsen Tennis Center Lounge, 530 Hibbard Road. Attendance is not mandatory.
- » All lottery times will be confirmed via email to the captain of the group.
- » The permanent court time lottery is open to all players who are 2021-22 season membership holders. Please read the following rules carefully.
- » Membership/lottery applications and fees are due on or before April 23, 2021.
- » All lottery applications must list at least three people in the playing group. No name may appear on more than one application.
- » All lottery application fees will be refunded if a court time is not selected. No refunds of season privileges will be given.
- » All lottery applications will be obligated for the total cost of their court period as assigned for the entire indoor permanent court time, Saturday, September 11, 2021 through Friday, May 6, 2022.
- » All applications should list 1st, 2nd and 3rd choices.
- » A \$6 guest fee will be assessed for those playing on permanent time who are not members of the A.C. Nielsen Tennis Center.
- » Please email Joe Holguin to cancel at jholguin@winpark.org. If you cannot use your time, staff will try to sell your time through the reservation process. If sold, a refund will be issued to the permanent court captain for distribution to the other players in the group.
- » Seasonal court times are not transferable and will be subject to cancellation and no new time assigned if the privilege is abused in any way with regard to the rules and regulations outlined herein.
- » Applications received after the drawing will be accepted and assigned their selection of seasonal court time from those available on a first-come, first-served basis.
- » The Winnetka Park District reserves the right to preempt permanent court time.
- » The following holidays will be excluded from the permanent court time season: Thanksgiving, Christmas Eve, Christmas Day, New Year's Eve, New Year's Day, and Easter Sunday.
- » Payment for the permanent court time will be made in two installments. Bills are sent to captains in September and January.

Lottery fees and three separate membership applications must be submitted by Friday, April 23, 2021 to be eligible for the lottery. No person shall be permitted to enter the lottery if such person owes the A.C. Nielsen Tennis Center any monies for the use of the facility. Three members are required per application; fourth name is optional. *Court Captain: The court captain is responsible for collection of all court fees and payment of fees to the Tennis Center on the prescribed dates. Refunds for permanent court time sold will be sent to the captain. I, the court captain, have read all the lottery rules and responsibilities and make the application for the lottery of permanent court time for the 2021-22 season.
