## WINNETKA PARK DISTRICT ORDINANCE NO. 596

## AN ORDINANCE RESTATING AND AMENDING LEASH REQUIREMENTS FOR DOMESTICATED DOGS

WHEREAS, the Winnetka Park District, Cook County, Illinois ("Park District"), is a duly organized and existing Park District created under the provisions of the laws of the State of Illinois, and is now operating under the provisions of the Park District Code of the State of Illinois, and all laws amendatory thereof and supplementary thereto (the "Park Code"); and

WHEREAS, Section 8-1(d) of the Park Code authorizes park districts to pass all necessary ordinances, rules and regulations for the proper management and conduct of the business of the Park District and to establish by ordinance all needful rules and regulations for the government and protection of parks under its jurisdiction; and

WHEREAS, the Winnetka Park District Board of Commissioners ("Board") is required to operate parks, beaches, and facilities in accordance with regulations established by the Village of Winnetka, the Cook County Department of Animal and Rabies Control, and other local, state, or federal governments with regulations applicable to the handling of domesticated dogs; and

WHEREAS, the Park District is the governmental entity with the authority to regulate the use of parks and property owned or controlled by the Park District pursuant to the Conduct Ordinance of the Winnetka Park District, Ordinance No. 504 (the "Conduct Ordinance"); and

WHEREAS, the Board has determined there is a need to restate and amend and restate Section 2.03 of the Conduct Ordinance, titled "Animals and Pets. Subsection (b) Certain Parks and Centennial Beach" to modify leash requirements for domesticated dogs in certain locations; and

WHEREAS, the Board hereby finds and determines it is in the best interests of the Park District and its residents to ensure domesticated dogs are properly leashed when occupying a Park District property or facility except when a property or facility may be operated lawfully as an off-leash facility and is authorized for such use by the Board.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF THE WINNETKA PARK DISTRICT, COOK COUNTY ILLINOIS, AS FOLLOWS:

<u>SECTION 2.03.</u> Animals and Pets. (b) Certain Parks and Centennial Beach is hereby restated and amended to read:

"Domesticated dogs are allowed in Arborvitae Park, Bell Woods, Centennial Park, all sand and bluff areas of Centennial Beach, Crow Island Woods, Franklin Dunbaugh Park, Hill Road Park, Merrill Park, Robert E. Burke Memorial Park, Sheridan Park, Skokie Playfield, Station Park and West Elm Park, provided that at all times the dog is on a leash not exceeding six (6) feet in length, is under the control of the owner or an agent of the owner and the owner or owner's agent has

in his or her immediate possession an appropriate bag, device or receptacle for the removal and transportation of dog excrement from such property and does, in fact, remove any excrement left by the dog from District Property."
