I further agree to waive and relinquish all claims I or my minor child/ward, may have (or that might accrue to me or my child/ward) as a result of participating in these programs/activities against the Winnetka Park District, including its officials, agents, volunteers and employees (hereinafter collectively referred as Winnetka Park District). I do hereby fully release and forever discharge the Winnetka Park District from any and all claims for disease, injuries, damages, or losses my minor child/ward, or I may have or which may accrue to me, my minor child/ward, or any other individuals arising out of, connected with, or in any way associated with these programs/ activities. Further, I do hereby indemnify, defend, and hold the District harmless from and against any and all claims, causes, injuries, damages and losses by third parties against the District arising from or in any way related to my or my child's/ward's participation in the identified programs/activities described above. I have read and fully understand the above important information, warning of risk, assumption of risk and waiver and release of all claims.
