Background:

The Winnetka Park District has been well-represented by Board Liaisons, President Archambault, Vice President Peterson and Commissioner James in long-standing discussions with the Village of Winnetka regarding their request for use of Park District properties for stormwater purposes. Extensive research, numerous detail oriented meetings and considerable negotiations have taken place in order to come to a successful resolution and the development of an Intergovernmental Agreement (IGA).

This collaborative effort has resulted in the presentation of a stormwater plan by Village of Winnetka representatives, Chris Rintz, Village President and Steve Saunders, Director of Public Works/Village Engineer to the Park Board at the February 20, 2020 meeting.

Prior to the meeting, the Board of Commissioners had been supplied with additional documentation that included exhibits for review.

Staff Recommendation:

As drafted by Park District Attorney, Steve Adams; staff recommends that the Park Board approve Ordinance No. 573.

This ordinance will serve as the file document of record memorializing this important action of intergovernmental collaboration.

ORDINANCE NO. 573

ORDINANCE APPROVING INTERGOVERNMENTAL COOPERATION AGREEMENT REGARDING STORMWATER IMPROVEMENTS AT CROW ISLAND PARK BETWEEN THE WINNETKA PARK DISTRICT AND THE VILLAGE OF WINNETKA

Recitals

WHEREAS, the Winnetka Park District, Cook County, Illinois ("Park District"), is a duly organized and existing Park District created under the provisions of the laws of the State of Illinois, and is now operating under the provisions of the Park District Code of the State of Illinois, and all laws amendatory thereof and supplementary thereto (the "Park Code"); and

WHEREAS, the Village of Winnetka, Cook County, Illinois ("Village") is a duly organized and existing Village created under the provisions of the laws of the State of Illinois and is now operating under the provisions of the Municipal Code of the State of Illinois, and all laws amendatory thereof and supplementary thereto (the Municipal Code"); and

WHEREAS, Section 8-11 of the Park Code authorizes the Park District to grant easements to municipalities for the construction, operation, and maintenance of facilities upon, under or across any property of such district for public services such as stormwater, subject to such terms and conditions as may be acceptable to the Park District; and

WHEREAS, the Village has established a comprehensive stormwater management plan under which a variety of conveyance, storage, and water quality improvements would be constructed on 17.6 acres of Park District-owned real property known as Crow Island Woods Park (the "Property"), in order to address long-standing and serious flooding in western and southwestern Winnetka; and

WHEREAS, The Park District desires to undertake certain improvements to improve stormwater conditions on the Property; and

WHEREAS, The Village has proposed an intergovernmental agreement under which the Park

District would grant the Village a permanent easement to enter the Property and to construct, operate maintain, repair and replace at its sole cost, certain stormwater improvements designed to alleviate flooding in Winnetka, and to construct certain improvements at its sole cost designed to improve stormwater conditions on the Property for the benefit of the Park District; and

WHEREAS, The Village and the Park District are empowered and authorized to enter into an Agreement for the construction, operation and maintenance of stormwater improvements on the Property, pursuant to the provisions of Article VII, Section 10 of the Illinois Constitution of 1970 and the Illinois Intergovernmental Cooperation Act, 5 ILCS 220/1 et seq.; and

WHEREAS, the Park District and the Village have engaged in extensive negotiations pertaining to the Village's proposed intergovernmental agreement, and the Board of Park Commissioners of the Winnetka Park District has now determined, and hereby declares, that it is appropriate and in the best interests of the District and its residents to enter into an intergovernmental agreement in substantially the form attached hereto as Exhibit 1.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF PARK COMMISSIONERS OF THE WINNETKA PARK DISTRICT, COOK COUNTY ILLINOIS, AS FOLLOWS:

SECTION ONE: The recitals set forth hereinabove shall be and are hereby incorporated in this Section One as if said recitals were fully set forth herein.

SECTION TWO: The Winnetka Park District Board of Park Commissioners hereby finds and determines that that entering into the Intergovernmental Cooperation Agreement Regarding Stormwater Improvements at Crow Island Park attached hereto as Exhibit 1 ("Intergovernmental Agreement"), and securing the stormwater benefits for the Property and for the Village, is in the best interests of the Park District and its residents, and no person holding any office of the Park District, either by election or appointment, is in any manner interested, either directly or indirectly, in his own name or in the name of any other person, association, trust or corporation, in said Intergovernmental

Agreement.

SECTION THREE: The Winnetka Park District Board of Park Commissioners hereby approves the Intergovernmental Agreement and hereby authorizes and directs the Board President and Board Secretary, to execute the Intergovernmental Agreement. The District's Board of Park Commissioners further authorizes and directs the District's Executive Director to deliver said Intergovernmental Agreement to the Village, and to take any and all other action necessary and proper to effectuate the terms of, and ensure compliance with, said Intergovernmental Agreement.

SECTION FOUR: All ordinances, resolutions, orders, or parts thereof in conflict with the provisions of this Ordinance be and the same are hereby repealed to the extent of such conflict.

SECTION FIVE: This Ordinance shall take effect upon its passage and approval in the manner provided by law.

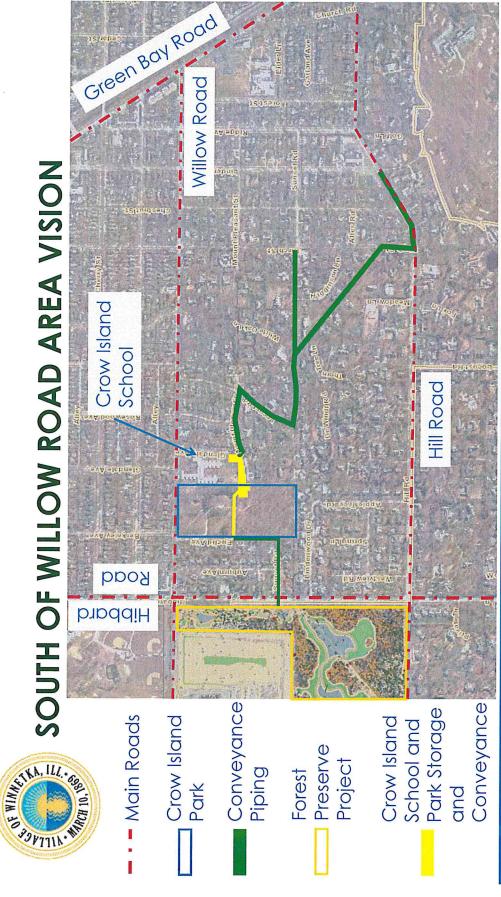

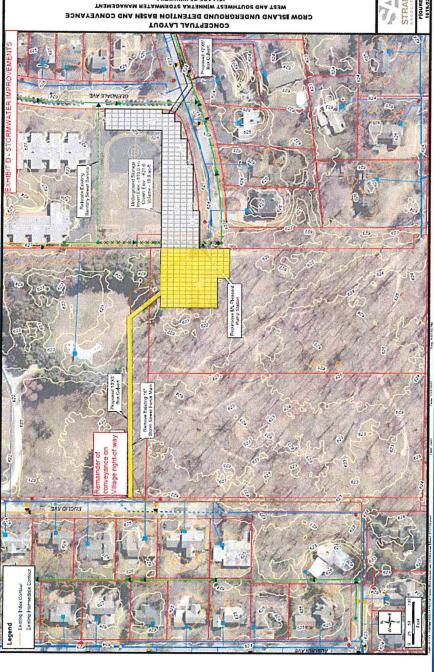

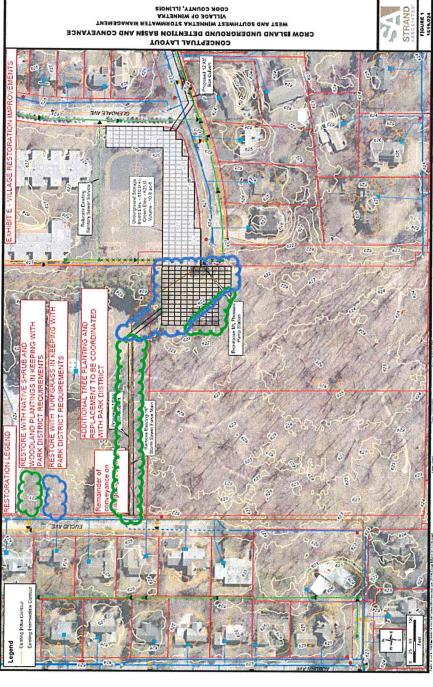

KEY BENEFITS OF PROJECT

- Storage area provides approximately 10.8 acre-feet of storm water storage, and is located mostly on both Crow Island School and Crow Island Park property.
- These properties are the only viable open space located south of Willow Road to provide stormwater storage and water quality volume benefits
- Storage and conveyance avoid traversing the Oak savanna on the Park property
- Provides an opportunity for potential drainage improvements for low-lying open space area near Mount Pleasant Street





KEY TERMS OF INTERGOVERNMENTAL AGREEMENT

- Defines scope and preliminary design of Village stormwater improvement
- Provides for cooperative design and review of project and provides shared project benefits
- Provides an easement agreement that allows stormwater storage on and under a portion of the property, and preserves Oak savanna on the property



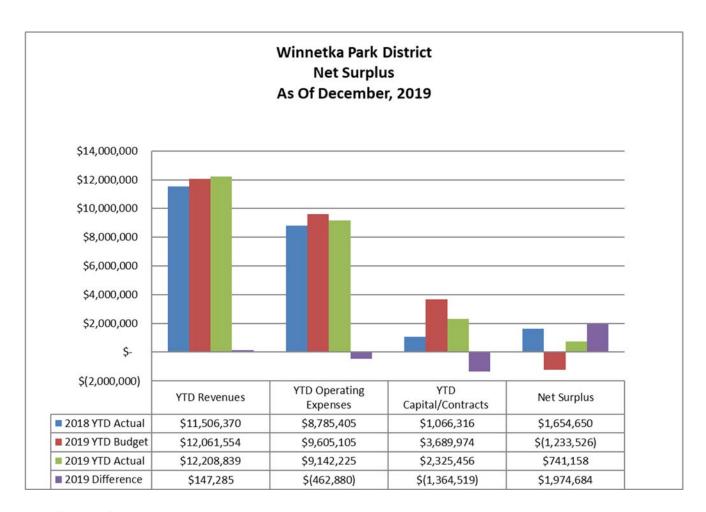

 - ➤ Unemployment compensation is under budget by \$36,209

 - ➤ Boat Launch contract services are under budget by \$21,957 due to dredging

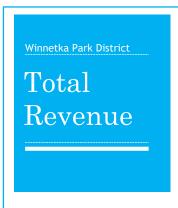
- Capitals are \$1,363,504 below budget. Over half of this (\$817,056) is being carried over to 2020 as part of the lakefront master plan improvements. Additionally, some projects will be deferred to future fiscal years due to the effect of other possible project timing (i.e. golf course storm water and lakefront masterplan improvements)
- Contracts Payable are \$1,015 under budget

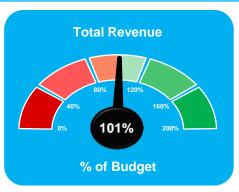

OLD BUSINESS:

Lakefront Conditions Update:

Superintendent Shea reported that the Parks Dept went down to Lloyd beach and removed the boardwalk and racks that were further damaged and falling as a result of another storm that took place January 10th – 11th. Any remaining vessels were also removed. Superintendent Kutulas reported that David Olson from the Illinois Emergency Management Agency (IEMA) reached out regarding the possibility of obtaining federal funding to recoup some of the losses from damage at the lakefront. The preliminary estimates totaled \$866,000 from that single event at all 5 lakefront locations. Superintendent Shea added that PDRMA conversations are continuing regarding previous damage and claims. Shabica & Associates have revised the permit for Lloyd Beach and recalculated the needs for sand etc. It is expected that the revisions will go out for public notice the week of February 10th. It was noted that Lake Michigan levels are on the rise; followed by presentation of a graph showing Lakes Huron and Michigan projected changes. Lake Michigan is currently 4 inches higher than the previous all-time high.

Superintendent Kutulas further reported that the bluff restoration permit is approved, waiting on 2 final bonds to receive final permit and begin initial work. They have been reaching out to the Village to formulate a plan in regards to public safety. Superintendent Shea has been communicating with the police dept.

Financial Advisor Selection

Superintendent Berman thanked the selection committee – Christine Codo, Eric Lussen and John Muno for the work on selecting a financial advisor group. They have settled on recommending Piper Sandler (formerly Piper Jaffray). She introduced John Balzano, representative for Piper Sandler who presented information regarding their company and vision for work with the Winnetka Park District. They currently work with approximately 25 area park districts. He also presented options for addressing debt service, fund balance draws and financing solutions to maintain a good rating. A question/answer session took place between Mr. Balzano and the Board, covering credit rating spreads, competitors, interest rates and sequencing of debt. John Muno thanked Commissioners Codo and Lussen, noted the good reputation of Piper Sandler whom he was introduced to through NSSRA and expressed that the Park District is excited to work with them. Vice President Peterson also offered thanks and noted that a visitor at the meeting has previously said that the Board should focus attention and energy on financial and intellectual pursuits rather than build parking lots; further noting that the staff and Board worked towards that challenge.

MATTERS OF THE DIRECTOR

Executive Director Muno reported that a follow up meeting was scheduled with the WPTC. Staff attended the IPRA State conference – met to discuss and brought thoughts back on a wide range of areas within our Park District. Legislative Breakfast will take place on February 14th – will be attending with Vice President Peterson, a good networking opportunity.

BOARD LIAISON REPORTS

Vice President Peterson – had a second meeting with a potential new leader for the Parks Foundation and a second person of interest to work with the Foundation. Looking to reset and having a positive start.

REMARKS FROM VISITORS

Rick Prohov – noted tie-ins between debt, precipitation, storm damage, lake forecasts and damage to facilities and capital expenditures and how climate change is impacting us locally. He encouraged the Board to commit to not doing the parking lot and trails at Tower over educating youth and demonstrating commitment to local initiatives for climate change.

Lynn Sanders – Winnetka resident, concerned about taking away resources like trees; please use caution

Ron White – brought up the subject of lake depths

Summary:

In order to comply with a newly enacted amendment to the Workplace Transparency Act, PA 101-0221 ("Act") the Winnetka Park District is asking the Board to review and pass Ordinance No. 574. The ordinance creates a reporting and investigative process for complaints of sexual harassment by one park board commissioner against another park board commissioner. The obligation to adopt this ordinance and incorporate this specific process into the District's Sexual Harassment Policy is found in Article 6 of the Act. This Ordinance will be added to the District's Sexual Harassment Policy that is currently under review as part of the District's Personnel Policy Manual.

Recommendation:

Staff recommends Board approval of Ordinance No. 574.

ORDINANCE NO. 574

ORDINANCE APPROVING WINNETKA PARK DISTRICT AMENDED SEXUAL HARASSMENT POLICY

WHEREAS, the Illinois General Assembly has enacted amendments to the State Officials and Employees Ethics Act in Public Act 101-221, some portions of which became effective August 9, 2019 (the "Act"); and

WHEREAS, the Act requires each covered unit of local government to, among other requirements, adopt an ordinance or resolution incorporating a specific procedure for the reporting and independent review of allegations of sexual harassment made against an elected official of the governmental unit by another elected official within 6 months after the effective date of the Act; and

WHEREAS, the Board of Park Commissioners of the Winnetka Park District has determined, and hereby declares, that it is necessary and in the best interests of the District and its residents to modify its current sexual harassment policy, in order to ensure full compliance with the Act.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF PARK COMMISSIONERS OF THE WINNETKA PARK DISTRICT, COOK COUNTY, ILLINOIS, AS FOLLOWS:

SECTION ONE: The recitals set forth hereinabove shall be and are hereby incorporated in this Section One as if said recitals were fully set forth herein.

SECTION TWO: The Winnetka Park District's Sexual Harassment Policy ("Policy") is hereby amended to comply with the Act by the addition of the following language as a new section in the Personal Policy Manual:

Any commissioner of the Winnetka Park District Board of Park Commissioners ("Park Board") who believes that s/he has been sexually harassed by another Park Board Commissioner may file a complaint with the Park Board President. If the Board President is the reporting person or is implicated by the allegation, the report can be made to any other Park Board Commissioner. Any report under this section must be referred to the District's legal counsel. The District's legal counsel shall promptly appoint a qualified independent attorney or consultant to review and investigate the allegations. The Executive Director and Board President are hereby authorized and directed to implement and administer the Policy in accordance with applicable law.

SECTION THREE: Any prior ordinance, resolution, policy or order of the Winnetka Park District in conflict with the provisions of the Policy or this Ordinance, shall be and hereby are, repealed to the extent of such conflict.
