

Fenced-In Rules and Regulations

- The boat must be in good working order and with no fluids leaking.
- The boat owner will be responsible for any damages within the fenced-in area, including damage to other boats and trailers.
- The overall length of the boat and its trailer must not exceed 27 feet. This measurement is from the tongue of the trailer to the end of the propeller.
- The width of the boat and its trailer must not exceed ten (10) feet.
- If either the length or the width of the boat and its trailer is greater than the stated measurement at any time, a boat owner will forfeit their fenced-in storage space and the Winnetka Park District (WPD) will not refund any money associated with the space.
- Trailers must be equipped to fit a 2" (two inch) ball for the WPD tractor to tow the boat.
- Each storage space is only for one (1) motorized boat or two (2) personal watercrafts on a single trailer.
- Fenced-in storage pass holders can call (847) 770-0821 up to two (2) hours in advance to have staff place their boat in the launch prior to their arrival.
- The boat must be covered while stored/sitting idle in the fenced-in area.
- No other items can be stored within the fenced-in storage area. A boat owner can store equipment within the boat but must still maintain the boat cover.
- Lloyd Beach is for the exclusive use of boating and sailing activities.
- Staff are present from Memorial Day through Labor Day.
- Staff hours are 7am to 9pm. At 9pm, visitors will be asked to leave and trespassers are subject to a fine from the Winnetka Police Department.
- If boaters are planning not to return to Lloyd Beach by 9pm, please notify the attendant at the time of launching.
- Owner/passenger must attend their boat at the time of launching. Staff members are not responsible for watching boats. The WPD is not responsible for any damages.
- Boats are required to have boat fenders present on the port or starboard side when launching and docking.
- Boats are required to have two (2) boat lines when launching and docking.
- Personal watercraft (PWC) hours are restricted to 9am to dusk, seven (7) days a week.
- Motorized boats can only anchor/switch passengers north of the beach house. Anchoring
 is not allowed south of the beach house.
- In compliance with the Illinois Boat Registration and Safety Act Digest, age of operations of personal watercrafts and power boats will be as follows:
 - o No persons under the age of 10 may operate a motorboat or PWC.
 - All children under the age of 13 must wear a personal floatation device on vessels less than 26 feet in length when underway, unless they are below decks in an enclosed cabin or on a vessel operating on private property.
 - o Persons at least 10 years and less than 18 years may operate a motorboat only if:
 - They are accompanied on the motorboat and under the direct control of a parent or guardian, or a person at least 18 years of age designated by a parent or guardian.
 - Persons at least 12 years and less than 18 years of age may, however operate a motorboat or PWC if:

They are in possession of a Boating Safety Certificate issued by the Department of Natural Resources Office, Division of Education, or a valid certificate issued by another state, a province of the Dominion of Canada, the U.S. Coast Guard Auxiliary or the U.S. Power Squadron.
