# Lloyd Shoreline Breakwater Change Order #1

Superintendent Shea presented a proposal to raise the stone breakwall up one (1) foot, putting the project 27% over budget, but within the 20% contingency dollar figure, and would provide added protection against rising lake levels. Shabica & Assoc. and Michels support the project and will still be on track time wise. Commissioner James suggested that it is a "one chance" project and a prudent thing to do. Executive Director Peterson asked the for the Board's support for action at the meeting on the 24<sup>th</sup>.

# **Lloyd Tier II Project Update**

Superintendent Shea reported that the next phase of work. The access road retention is under review and he updated those plans as well as the deliveries of sand, referencing time-lapse videos for a visual reference. He further added that the crew is excellent and the project is going very well. A brief discussion took place regarding soil boring, retaining walls and evidence of the project's success thus far.

# **Tower Road Beach Project Update**

Superintendent Shea reported that the steel mesh has been ordered, with a lengthy lead and install time, but is the last part of the project. Pizzo will be installing plantings and notifying neighbors of a controlled burn to take place in October. President Archambault stated that the construction delays from the contractor have been more than frustrating.

# **Budget Update**

Superintendent Berman is collecting budget information from staff. She and Executive Director Peterson would like to have some one-on-one meetings with the Board in preparation for the meetings in November. Preliminary numbers for August suggest a positive net income of \$20,000.00, up for all operating funds, with a cumulative net income of \$460,000.00. In response to President Archambault's query regarding budget plans with COVID in mind, Executive Director Peterson noted that we do not want to lose sight of some expense items, although they may be different in the coming year. He further added that the District learned a lot in 2020, particularly in the ways that staff reacted to manage and maximize revenue opportunities.

# **BOARD LIAISON REPORTS**

Fall Fest will be different this September 26 and will also feature an "adults only" comedy show in the evening. He further reported that flag football had a robust number of participants and outdoor activities have increased, including yoga. Commissioner Seaman questioned the economics regarding the comedy shows to which Executive Director Peterson noted were less oriented to the bottom-line this year. Alternatives for outdoor facilities as the weather changes were briefly discussed and respect for District 36's attention to COVID 19 exposure was noted.

# 2020 John Deere 4052R Compact Utility Tractor Purchase

A motion was made by Commissioner Claybrook to approve the purchase of (1) new "2020 John Deere 4052R Compact Utility Tractor" from J.W. Turf Inc. of Elgin, Illinois with the configuration shown on the quote as presented through the Sourcewell bid for the net price of \$30,666.64 which includes the trade-in allowance of \$500. Commissioner Seaman questioned the purchase review process and choice of brand. Superintendent spoke to the Sourcewell government pricing at 18% under list and selection of a demo item. # **Lakefront Update**

Superintendent Kutulas provided an update on the progress at Lloyd Beach, noting the work Michels has done and looking to completion in November. A visual presentation was given regarding the Tier II portion of the project per the Lakota Group design plan, with some of the highlights to include: the boardwalk, access from the parking lot to the non-motorized section and parking lot remediation. The plan also includes keeping the access point from the service road and bluff restoration. A brief question and answer exchange took place.

Superintendent Kutulas also gave a brief update on the work at Tower Beach, reporting that we are awaiting delivery of steel mesh to complete the last phase, hopefully by the 2<sup>nd</sup> week of November. Pizzo & Assoc. will be conducting controlled burns and seeding. Lighting will be focused on the stair treads.

# **Proposed Conveyance of Real Property**

Executive Director Peterson reported on the progress to complete the transaction. A public meeting is to take place September 29 at 5:30 p.m., 3 meeting notices were placed in different publications by Kelsey Raftery. Commissioners Archambault and James expect to be present in-person in the Community Room, no more than four staff members in person, leaving room for some public participation if needed. Board and staff participation will be via Zoom.

Executive Director Peterson relayed that he is reviewing crisis management for cyber breach response and looking into a service provider. Thank you to Kelsey for her solo efforts for various marketing initiatives.

### STAFF UPDATES

**Superintendent of Finance, Christine Berman** – The 2020 Budget had an item for a \$182,000 building commitment to NSSRA that will be paid in thirds - December 2020, January and February 2021.

**Superintendent of Parks, Costa Kutulas** – He gave a brief update on outreach items and smaller park projects. The rendering of Lloyd from The Lakota Group was touched on and he asked if there were further questions. Commissioner James noted the additional stone around the beach house and suggested checking with Scott Freres in order to clarify the plans, a discussion about the cage and other stone took place.

Commissioner James suggested inclusion of liquidated damages provisions to whomever we award the contract.

# **NEW BUSINESS**

President Archambault relayed that the purpose of this special meeting was to provide the public with notice of the Park District's plan to exchange real estate owned by the Park District for other land along the lakefront between Elder Lane Park and Centennial Park.

Commissioner James provided a description of the proposed conveyance, emphasizing that it was a long-desired goal of the Park District and within the plans of the Winnetka Waterfront 2030 Master Plan, which was approved in 2015. The Master Plan identified a privately owned parcel of property that has been of keen interest of the Park District to acquire for many years. That property will be acquired in exchange for a similarly sized parcel on the south end of Centennial Park. The combination of the Elder Land and Centennial Beach properties will provide the public with nearly 1,000 feet of continuous shoreline and nearly 8 acres of parkland. It was noted that the parcel of real estate is of

considerably greater value than the value of the property the Park District is conveying, thanks to the generosity of a Winnetka resident.

This public meeting will be followed by a Board meeting to approve an ordinance to move forward with the exchange agreement, due diligence and closing on the property exchange.

Superintendent Kutulas provided a visual storyboard presentation explaining the details of the project. He reviewed the Winnetka Waterfront 2030 Lakefront Master Plan, the parcel at 261 Sheridan Road and the parcel at the south end of Centennial Park.

Commissioner James added that the property exchange will be a typical real estate transaction and normal steps are to be taken. President Archambault offered his thanks.

# **REMARKS FROM VISITORS**

**David McHugh ...** offered criticism that no regular notice was provided village wide as would be required with a referendum. He questioned why the Park District did not buy the 261 Sheridan property outright to which President Archambault acknowledged that the WPD was outbid. Commissioner James clarified that once the property is exchanged, it will no longer be public property and further plans are not the responsibility of the Park District. Mr. McHugh also expressed concern over historical intent and Executive Director Peterson responded accordingly.

**Judy & Jim Rauh** ... stated that they are new to the Village of Winnetka and thought that the purchase of their home would be a safe investment across from a public park, and did extensive design work on their home intended to preserve the view. They are concerned that this is will impact the value of their home and be a precedent setting action.

**Rebecca Ferguson** ... said that they were building their house because they wanted to be close to the beach for their child with special needs. They were disappointed that there was not communication from the Park District. While she is supportive of some aspects of the Master Plan, she expressed concern as to what the future plans may be (i.e. green space) and that they may impinge on the views for others.

**Ankur Joshi** ... purchased their home based on the view and desire to escape the uncertainty of development in the city. He suggested that Park District take into consideration the the views of residents in making decisions.

**Stephanie Heraty** ... expressed disappointment since the residents did not have time to make their voices heard and emphasized that they do not want the parkland to be compromised.

# **REMARKS FROM VISITORS - cont'd**

**Claudia Goodrich** ... expressed that she wants the Park District to take the views of residents into account. Upon moving from the city, they were looking for greenery, space and stability when they bought their home. She expressed shock that the Park District would shrink a public park, further noting surprise and disappointment.

**Richard Coasby ...** said he was shocked and disappointed that this wasn't communicated and being held to ransom in this way. He asked for clarification of the financial aspects of the transaction to which Commissioner James responded, but he further disagreed with the valuation.

**Betty Finken** ... questioned the lack of communication and suggested that perhaps had residents known, someone would have donated the property, further suggesting that residents should vote on changes to the plan. She appreciated the Board's time.

**Randy Whitchurch** ... said that he was stunned that no notification was supplied to the residents of Fuller Ln., suggesting that it is malpractice. He emphasized that everybody on Fuller Lane is affected by this.

**Steve Adams** ... Attorney for the Winnetka Park District stated that the Park District has followed to the letter, the requirements and process outlined by State of Illinois law. The Master Plan process involved extensive discussions about the parks and how they would be affected by this transaction. A very public process took place in making decisions about a hugely important element to provide quality services to the community. He is certain that the Board will weigh the comments made at this meeting and keep in mind the best interest of the community as a whole. He noted that it is a different process than what would be required by a village zoning change and the accusation that the transaction is malpractice is unfounded.

**Commissioner James** ...said that he appreciated the comments expressed by the residents and their concerns. He further emphasized the Park District's efforts and the financial strain it has caused. He looks forward to the benefit that will be enjoyed by the residents.

**Alan & Meaghan Weed ...** letter read by President Archambault... stated that they are supportive of the Winnetka Waterfront 2030 Plan. They are concerned and emphasized their desire for the Board to be mindful of the aesthetics of the plans, in particular regarding the parking lots and attention to plantings. They are thankful for the consideration.

**Judy & Jim Rauh ...** spoke again, acknowledging that the difference in property value is due to presence of a house. They are disappointed that the Board has not acknowledged the negative impact on resident, it seems like that Park Board does not care about stakeholders, and should have sought other funding rather concede to a once in a lifetime opportunity.

### REMARKS FROM VISITORS - cont'd

**Dave Chung** ... asked for confirmation that the individual in the swap is the owner of the property at 205 Sheridan Rd. Executive Director Peterson confirmed that. Mr. Chung suggested that this will be a significant increase in value to that property as a whole and further suggested offering a smaller parcel of land instead due to the value conveyed.

**Andy Goodrich** ... questioned the plans for redevelopment. President Archambault clarified that once the transaction is complete, it will be a private property, subject to the Village's requirements and cautioned that I it was not necessary to make negative assumptions.

**Beth Skalla...** said that this appears to be a forum of neighbors and questioned plans to open the plans for the land swap to the whole community. President Archambault said that it is public and has been in three publications. Steve Adams added that it is a part of the Master Plan.

**LeeAnn Rechtin** ... spoke of the historical problem of cars cutting through the Fuller Ln. neighborhood and wondered if the street could be made private to avoid people cutting through to the park. She also suggested adding aesthetics to improve their view and questioned what happens if the transaction does not go through.

**Bill Cadigan ...** questioned process and changes of residential use and incompatibility with park use and the Master Plan. President Archambault and Commissioner James emphasized that zoning is the purview of the Village of Winnetka. Suggested that the Board find out more about plans before conveying the property.

**James McLaughlin** ... said that his father was on the Park Board when they considered purchasing the house in question at 261 Sheridan, felt its disconcerting that there has been no communication. Very real concerns from the people present at the meeting. Would like to see a bigger audience.

**Betty Finken** ... messaged a question if the Board considered less feet for the swap – has the final decision been made? President Archambault noted that it has not been voted on, but the Board is in favor.

## **Summary:**

The Truth in Taxation Law requires not less than 20 days prior to the adoption of its aggregate levy the corporate authority of each taxing district shall determine the amount of money, exclusive of levies for debt service and election costs, estimated to be necessary to be raised by taxation for that year upon the taxable property in its district.

Attached please find Resolution #20-10-22 that is scheduled for approval at the October 22, 2020 Board Meeting. As you can see by this resolution, the proposed 2020 tax levy, exclusive of debt service, is estimated to be \$5,860,454. This amount is 4.80% more than the 2019 extension amount, exclusive of debt service, of \$5,591,960.

A public hearing on the tax levy is required if the amount is more than a 5% increase. As such, a public hearing is not necessary for the 2020 Tax Levy.

Staff recommends Board approval of Resolution #20-10-22.

The amount of real estate taxes, exclusive of election costs, public building commission leases and debt service levies, extended by the Park District, plus any amount abated by the Park District before extension, upon the final 2019 real estate tax levy of the Park District (collected in 2020) is \$5,591,960.
- **2.** The amount of real estate taxes, exclusive of election costs, public building commission leases and debt service levies, proposed to be levied by the Park District for 2020 (collected in 2021) is \$5,860,454.
- **3.** Based on the foregoing, the estimated percentage increase in the proposed 2020 aggregate levy over the amount of real estate taxes extended upon the final 2019 aggregate levy is 4.80%, and that, accordingly, no public hearing or publication is required under the Truth in Taxation Law.

# PERMANENT EASEMENT AGREEMENT FOR THE INSTALLATION AND MAINTENANCE OF A PAD MOUNT TRANSFORMER AND ASSOCIATED CONDUIT AND CABLES

THIS AGREEMENT ("Agreement") is dated as of the 6th day of 0ctober, 2020, ("Effective Date") and is by and between the WINNETKA PARK DISTRICT, an Illinois park district ("Owner"), and the VILLAGE OF WINNETKA, an Illinois home rule municipal corporation ("Village").

#### WITNESSETH:

WHEREAS, the Owner is the record title owner of that certain property commonly known as Indian Hill Park, located at the address commonly known as 131 Wilson Street, Winnetka, Illinois, and legally described in Exhibit A attached to and, by this reference, made a part of this Agreement ("Property"); and

WHEREAS, in order to improve the reliability and appearance of the electrical service serving both the residential customers on Bertling Lane in the Village and the Winnetka Park District's Indian Hill Park, the Village desires to remove a portion of the overhead electrical facilities and construct and maintain on a portion of the Property: (i) a pad mount transformer ("Transformer"); and (ii) associated underground conduit and cables (collectively, "Conduit") (the Transformer and the Conduit are, collectively, the "Facilities"); and

WHEREAS, to construct, maintain, and repair the Facilities on the Property, the Village desires to obtain from Owner, and Owner desires to grant to the Village a permanent easement on that portion of the Property depicted in **Exhibit B** attached hereto and made a part of this Agreement ("Permanent Easement Premises"); and

WHEREAS, Section 8-11 of the Park District Code authorizes Owner to grant easements to municipalities, corporations or persons for the construction, operation and maintenance of facilities upon, under or across any Owner property for various utilities including for water or other public services; and

WHEREAS, the Owner and the Village have each determined that it is in each of their best interests to enter into this Agreement;

**NOW, THEREFORE**, in consideration of the recitals, mutual covenants, and agreements set forth herein and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Owner and the Village agree as follows:

SECTION ONE. RECITALS. The foregoing recitals are fully incorporated into this Agreement.

SECTION TWO. GRANT AND USE OF PERMANENT EASEMENT. The Owner hereby grants, conveys, and dedicates to the Village a permanent non-exclusive easement in, upon, over, under, through, along, and across the Permanent Easement Premises ("Permanent Easement") and a perpetual license to access a reasonable portion of the Property for ingress and egress to the Permanent Easement and to engage in the construction, operation, maintenance, repair, and replacement of the Facilities from time to time, subject to the terms and conditions of this Agreement, together with all reasonable rights of ingress and egress over, along, upon, and across the Permanent Easement and the immediately abutting area of the Property, if necessary, for the exercise of the rights herein granted. The Permanent Easement granted pursuant to this Section 2 shall not be used or operated for any purpose other than the Permitted Activities. The Permanent Easement shall not be used or operated in a manner that materially interferes with Owner's use of the Property now or in the future; provided, however, that the installation and construction of the Facilities and the normal operation, maintenance, repair, and replacement of the Facilities shall not be considered material interference.

SECTION THREE. RESTORATION. Upon completion of the initial installation of the Facilities, the Village agrees to (a) replace any and all topsoil removed by the Village; (b) restore to condition immediately preceding the installation of the Facilities any and all fences, roads, curb cuts, parking indicators (e.g. signs, curbs or striping), plantings, and improvements that are damaged or removed as a direct result of the installation of the Facilities; (c) replace any and all sod removed with sod of like quality; and (d) replace any and all natural grass removed by seeding with a good quality seed. Subsequent to completion of the initial installation of the Facilities, if the Village conducts ongoing maintenance, repair, or replacement of the Facilities, the Village agrees to (w) replace any and all topsoil removed by the Village; (x) restore to condition immediately preceding the installation any and all fences, roads, curb cuts, parking indicators (e.g. signs, curbs or striping), plantings, and improvements that are damaged or removed as a direct result of the maintenance, repair, or replacement of the Facilities; (y) replace any and all sod removed with sod of like quality; and (z) replace any and all natural grass removed by seeding with a good quality seed.

SECTION FOUR. LIENS. Each Party hereby represents and warrants to the other that they will each take all necessary actions to keep the Permanent Easement Premises free from any liens or encumbrances, including, without limitation, the lien of all mortgages, mechanics' lien claims, security agreements, and assignments of rents and leases.

## <u>SECTION FIVE</u>. <u>RESERVED RIGHTS</u>.

A. The Owner hereby reserves the right to the full use and enjoyment of the Permanent Easement Premises and the Property in any manner that does not prevent or interfere in any way with the exercise by the Village of the easement rights granted pursuant to this Agreement; provided,

however, that the Owner shall not permanently or temporarily improve, disturb, damage, destroy, injure, or obstruct the Permanent Easement Premises, nor intentionally permit the Permanent Easement Premises to be permanently or temporarily improved, disturbed, damaged, destroyed, injured, or obstructed, at any time whatsoever, without the express prior written consent of the Village.

**B**. The Owner shall have the right to grant other non-exclusive easements over, along, upon, or across the Permanent Easement Premises provided, however, that any such other easements shall be subject to this Agreement and the rights granted hereby; and provided further, however, that the Village shall have first consented in writing to the terms, nature, and location of any such other easements.

**SECTION SIX. ASSIGNMENT OF RIGHTS.** The Owner agrees that the Village may assign its rights or delegate its duties under this Easement Agreement, in whole or in part, without the consent of the Owner.

SECTION SEVEN. COVENANTS RUNNING WITH THE LAND. The easements and rights granted in this Agreement, the duties and restrictions imposed by this Agreement, and the agreements and covenants contained in this Agreement are easements, rights, restrictions, agreements, and covenants running with the land, are to be recorded against the Property and are binding upon and inure to the benefit of the Owner and the Village, and their respective heirs, executors, administrators, grantees, successors, assigns, agents, licensees, invitees, and representatives, including, without limitation, all subsequent owners of the Permanent Easement Premises, or any portion thereof, and all persons claiming under them. If any of the easements, rights, restrictions, agreements, or covenants created by this Agreement would otherwise be unlawful or void for violation of (a) the rule against perpetuities or some analogous statutory provision, (b) the rule restricting restraints on alienation, or (c) any other statutory or common law rules imposing time limits, then such easements, rights, restrictions, agreements, or covenants will continue only until 21 years after the death of the last survivor of the now living lawful descendants of the current President of the United States.

## SECTION EIGHT. INSURANCE REQUIREMENTS; INDEMNIFICATION.

- A. The Village shall require all of its contractors and subcontractors hired to perform any work on the Easement Premises to maintain insurance in the types and amounts specified below, to protect the Owner and the Village against claims arising directly or indirectly out of, or in connection with, the Village's conduct of the construction activities or the Village's use of the Easement Premises or the Property pursuant to this Agreement:
  - 1. Worker's Compensation and Employer's Liability with limits not less than:
    - (a) Worker's Compensation: Statutory;
- 2. Commercial Motor Vehicle Liability with a combined single limit for bodily injury and property damage of not less than \$1,000,000 per occurrence for vehicles owned, non-owned, or rented.
- 3. Commercial General Liability with coverage written on an "occurrence" basis and with "per project" limits no less than a combined single limit for personal injury, bodily injury and property damage of \$1,000,000 per occurrence and \$2,000,000 general aggregate.

The Village shall cause any contractor or subcontractor performing work on the Easement Premises to name Owner as an additional insured prior to commencing any such activity and shall provide to the

Owner a copy of a Certificate of Insurance evidencing the same.

B. Indemnification. To the fullest extent permitted by law, the Village agrees to indemnify, defend and save the Owner, its elected officials, officers, employees, agents, and volunteers harmless from and against any and all liabilities, claims, losses, or demands for personal injury or property damage arising out of or caused by any act or omission of the Village, any of its contractors or subcontractors, anyone directly or indirectly employed or engaged by any of them, or anyone for whose acts any of them may be liable, arising from the Village's construction, operation, maintenance, repair, and replacement of the Facilities or exercise or use of the easement rights granted under this Agreement. The obligations on the part of the Village to indemnify, defend, save and hold harmless the Owner shall survive the expiration or termination of this Agreement.

## SECTION NINE. GENERAL PROVISIONS.

A. Notices. All notices required or permitted to be given under this Agreement must be given by the parties by: (i) personal delivery; (ii) deposit in the United States mail, enclosed in a sealed envelope with first class postage thereon; or (iii) deposit with a nationally-recognized overnight delivery service, addressed as stated in this Section 9.A. The address of any party may be changed by written notice to the other parties. Any mailed notice will be deemed to have been given and received within three days after the same has been mailed and any notice given by overnight courier will be deemed to have been given and received within 24 hours after deposit. - **B.** Amendment. No amendment or modification to this Agreement will be effective until it is reduced to writing and approved and executed by the governing boards of each party to this Agreement in accordance with all applicable statutory procedures.
- C. <u>Authority to Execute</u>. The Village hereby warrants and represents to the Owner that the persons executing this Agreement on its behalf have been properly authorized to do so by the Village. The Village accepts the Permanent Easement Premises in an as-is and where-is condition. The Owner hereby warrants and represents to the Village that: (i) the Owner is the record and beneficial owner of fee simple title to the Permanent Easement Premises; (ii) no other person has any

legal, beneficial, contractual, or security interest in the Permanent Easement Premises; (iii) the Owner has the full and complete right, power, and authority to enter into this Agreement, to agree to the terms, provisions, and conditions set forth in this Agreement, and to bind the Permanent Easement Premises as set forth in this Agreement; (iv) all legal actions needed to authorize the execution, delivery, and performance of this Agreement have been taken; and (v) neither the execution of this Agreement nor the performance of the obligations assumed by the Owner will violate any statute, law, restriction, court order, or agreement to which the Owner or the Property are subject.

- **D.** Recording. The Village at its cost and expense will record this agreement against the Property with the Office of the Cook County Recorder of Deeds promptly following the approval and full execution of this agreement by the parties.
- E. <u>Non-Waiver</u>. The Owner and the Village shall be under no obligation to exercise any of the rights granted to each of them in this Easement Agreement. The failure of either party to exercise at any time any right granted to such party shall not be deemed or construed to be a waiver of that right, nor shall the failure void or affect either party's right to enforce that right or any other right.
- F. No Waiver of Tort Immunity. Nothing contained in this Agreement shall constitute a waiver by the District or the Village of any right, privilege or defense which it has under statutory or common law, included but not limited to the Illinois Local Governmental and Governmental Employees Tort Immunity Act, 745 ILCS 10/1-101 et seq.
- G. <u>Severability</u>. If any provision of this Easement Agreement is construed or held to be void, invalid, illegal, or unenforceable in any respect, the remaining part of that provision and the remaining provisions of this Easement Agreement shall not be affected, impaired, or invalidated thereby, but shall remain in full force and effect. The unenforceability of any provision of this Easement Agreement shall not affect the enforceability of that provision in any other situation.
- H. <u>Interpretation</u>. This Easement Agreement shall be construed without regard to the identity of the party who drafted the various provisions of this agreement. Moreover, each and every provision of this Easement Agreement shall be construed as though all parties participated equally in the drafting of this Easement Agreement. As a result of the foregoing, any rule or construction that a document is to be construed against the drafting party shall not be applicable to this Easement Agreement.
- I. <u>Survival</u>. All representations and warranties contained herein shall survive the execution and recordation of this agreement and shall not be merged.
- J. <u>Entire Agreement</u>. This Agreement constitutes the entire agreement between the parties and supersedes any and all prior agreements and negotiations between the parties, whether written or oral, relating to the Easement granted pursuant to this Agreement.
- **K.** <u>No Third Party Beneficiaries</u>. No claim as a third party beneficiary under this Agreement by any person may be made, or be valid, against the Village or the Owner.
